+ **RE-CONSIGNMENT OR DIVERSION (ITEM 820)** Charges for reconsignment of a shipment will be assessed in two parts: a \$75.00 administrative fee applicable to ALL reconsigned shipments, and recalculated linehaul charges based on point of origin, point of reconsignment, and corrected destination point. Additional labor fees may apply. Please see ODFL 100-Q Item 820 for exceptions and full details.

**CAPACITY LOAD - OVERFLOW (ITEM 390)**

Shipments requiring linear length of 20 feet or greater, or quantity of freight 20,000 pounds or greater, regardless of linear footage or cubic capacity required. For complete listing of the determining criteria and rates, see ODFL 100 series, item 390.

**CUSTOMS, IN BOND FREIGHT OR CROSS BORDER FREIGHT**

**COMMODITY DESCRIPTION**

To ensure assessment of correct freight charges and avoid infractions of federal and state laws, customer or shipper is required to acquaint themselves with the proper description of articles for the commodities being shipped in accordance with the NMFC. Failure to list class or description defaults to class 100. Abbreviated descriptions are permitted provided the NMFC item number and appropriate sub number are shown on the bill of lading. Carrier reserves the right to inspect the contents of packages and weigh the shipment to verify shipper has recorded accurate descriptions and weights on the bill of lading. In the event Carrier determines the commodities have been incorrectly described, customer will be liable for the freight charges based on the correct descriptions and weights and determined by Carrier. (See NMFC Series 100 item 360; ODFL 100 series, items 170; 360; 361; 367; and 994)

**FAILURE TO MAKE A TIMELY PAYMENT OF CHARGES (ITEM 564)**

Carrier must receive full payment of freight charges within 42 days from the original invoice due date to avoid payer being charged an assessment of liquidated damages in an amount equal to 35% of the unpaid receivable.

**MINIMUM CHARGE FOR LOW DENSITY FREIGHT (ITEM 610-1)**

1. Shipments less than 3 pcf and requiring between 350 and 749 cubic feet, or
2. Shipments less than 6 pcf and requiring 750 cubic feet or more.

**MAXIMUM CARRIER LIABILITY - ARTICLES OF EXTRAORDINARY VALUE (ITEM 594)**

Between 48 contiguous states (New commodities - Max \$5.00 per pound. or \$50,000 per occurrence.)

**PURCHASE OF CARGO LIABILITY (ITEM 574)**

ODFL can secure cargo liability, exceeding the default liability limits set forth in item 594 using truck conveyed transportation. Call Customer Service at 800.235.5569 or obtain a rate through ODFL.com.
